

Atlantic Builders Convention (ABC) – April 14-16, 2010 Selling on the Exhibit Floor Addendum

For the first time in the history of the Atlantic Builders Convention (ABC), Exhibitors will be allowed to sell their products/services on the exhibit floor. The ABC feels this change will be a benefit to its attendees as well as its exhibitors since "ABC Show Specials" will increase the value of attending in current and future years.

In order for Exhibitors to take advantage of this opportunity the following steps must first be adhered to:

1. All Exhibitors must read this addendum, sign, complete and return it to the NJBA/ABC office by March 30, 2010.
2. Exhibitors who wish to take advantage of this new opportunity must submit a copy of their sales tax registration certificate the NJBA/ABC office by March 30, 2010. Certificates can be faxed or mailed to the fax number or address provided below.
3. The sales of products/services must be related to the building industry. The ABC Show Management reserves the right to approve or deny which products will be sold on the show floor. The ABC Show Management also reserves the right to forbid the selling of any non pre-approved building industry related products.
4. At the ABC show, Exhibitors must display a copy of their sales tax registration certificate in a visible area of their booth throughout the three days of the convention to be sure they are in compliance. The NJBA/ABC Show Management reserves the right to deny an Exhibitor's selling privileges on the floor if they are not meeting the requirements listed.
5. The NJBA/ABC will not be responsible for any lost or stolen Exhibitor products during set-up days, the three day show and break-down periods. The NJBA/ABC will offer; however, a locked storage room for those exhibitors who would like to store their items away after show hours. It will be the Exhibitors responsibility to transport their items to and from the locked storage room.
6. It is Exhibitor's responsibility to obtain and display any and all permits, licenses, or clearances necessary for Exhibitor to sell products/services on the exhibit floor.
7. By signing this agreement Exhibitors agree to collect, remit and report their own sales tax to the State of New Jersey. The ABC/NJBA are not responsible for the collection, remittance or reporting of sales tax to the State of New Jersey on behalf of any ABC exhibitor.
